# LEASE RENEWAL REMINDER

Payment is due April 1st for those shareholders that took advantage of the split payment option for the annual 2023-2024 lease renewal. If payment of \$750 is not received in the CWC office by April 30th, 2024, a \$100 late fee will incur.



It takes a Village! Or in our case, a community to manage costs...

One of the amenities provided by CWC is the pickup / disposal of household garbage. There are 43 waste containers and 13 recycling containers provided by CWC available around the lake. Also, CWC has negotiated permits for dumping at Pinehill Landfill.

When the containers over-flow the top, there are overage charges for each bin at each pickup. Pictures are automatically taken and tagged. These costs can add up quickly. To give you an idea, over



a 3 month time period, the costs were approximately \$2500. If we continue this trend, overages could run around \$10k for the year.

There are some pictures below as an example.

How can you help keep our costs within budget? When you go to drop off your trash, if the bin is overflowing, please put your trash in another bin. Also, breaking down your boxes will allow for more trash in each dumpster.

Another suggestion is to consider the timing of when you drop off your trash. Trash is picked up on Wednesday and Saturday with recycle picked up on Thursday. During slow months, CWC



Maintenance will drive around the lake on Tuesday afternoons to check the waste containers. This is only a temporary solution.

We are seeing building materials in the waste containers. If you are building, your contractors are responsible for the removal of all building materials from CWC property (Rule III Section D). You are probably already paying for the removal as part of your contract with your builder. Let's not incur additional costs for materials that are not disposed of properly. Please remind your builders they can't use waste containers for the disposal of their materials.

We all know that costs are continually rising. Small changes can make a difference to the overall service costs.

### MINUTES OF THE BOARD OF DIRECTORS CHEROKEE WATER COMPANY February 15, 2024

A meeting of the Board of Directors of Cherokee Water Company was held at 6:00 pm on Thursday, February 15, 2024, at NK 20 Lake Cherokee, Longview Texas 75603 with the following Directors present:

President Gary Mapes called the meeting to order at 6:00 pm Dee Rea, Secretary pronounced a quorum.

Dee Rea made a motion to Approve the minutes from January 18, 2024. Seconded by Thomas Merritt. The motion was approved unanimously.

### General Manager's Report

Kevin provided an operation report including stats on administrative, patrol and maintenance departments. Items of notice were the ATT phone bill went from \$2700.00 per month down to \$200.00 per month by consolidating different phone lines. Cathy Hite is making progress with the online store. It is projected that 6 to 10 items will be available to purchase with the Lake Cherokee logo on them.

The covered patio is finished at the office. This will allow the water company to host wedding events, the chili cook off and the wet and wild boat rally.

The water company sold water to the Valence Operating Company to finish fracking a well for \$104,000.00.

### Treasurers Report:

- Randy Graves, Treasurer made a motion to certify the bills paid for the month ending January 2024. Seconded by Dee Rea. The motion passed unanimously.
- Randy Graves made a motion to approve the Financials ending January 2024. The second was made by Dee Rea. The motion passed unanimously.

### **Committee Reports:**

### Natural Resources Committee Thomas Merritt, Chairman:

The Natural Resources Committee met at a regularly called meeting February 12, 2024. Chairman Thomas Merritt called the meeting to order.

The following summarizes items discussed and actions taken.

Reviewed the recommendation from Canvas Natural Resource, LLC to perform the 2nd thinning of the planted pine timber on the SZ-Stephens lease, southwest of Lake Cherokee. This is a prudent action towards management of CWC timber resources and revenue generation. The net income to CWC is estimated to be in the \$30k to \$50k range. The tract is located miles from the nearest shareholder lots and is accessed via county roads and should therefore have little to no adverse impact on the shareholder community. Before and after photos can be taken for potential future use in case study communications.

Four CWC Board Members and the General Manager met with CP&Y Engineering at the dam & spillway on 2/8/24. The group observed and inspected the current conditions of existing infrastructure and the new hog fence.

Committee member Seleta Davis contacted the Texas Water Development Board to request an isopach map showing the difference in sediment thickness from the previous 2015 Volumetric & Sedimentation Survey, to the most recent. The Texas Water Development Board responded to let us know that they will provide this as soon as possible.

Thomas Merritt made a motion to proceed with the thinning of trees in the SZ-Stephens Lease. Second was made by Rhonda Bullard. The motion passed unanimously.

# Rules and Policies Committee Paul Oberthier, Chairman

The Rules and Policy Committee discussed an issue regarding shares of stock being in one shareholder's name if a building crosses lot lines. The CWC's legal counsel recommended keeping shares of stock in one name if structures are built across lot lines owned by the same shareholder. The committee will meet to discuss the process for managing this situation.

Two variances were submitted for review:

- 1. SS-05 requested a variance to build a house and in ground pool closer than 75 feet to the water. The compliance officer worked with the shareholder to move the proposed structure being built 10 feet farther back from the water's edge. A variance was still required since the house to be built is closer to the water than 75 feet. Paul Oberthier made a motion to approve this variance. A 2nd was made by Randy Graves. The motion passed unanimously.
- 2. SP-32 requested a variance to replace a wooden deck that will be closer than 75 feet to the water. **Paul Oberthier**

made a motion to approval the variance. A second was made by Randy Graves. The motion passed unanimously.

**Community Relations Committee:** Kristina Coolidge, Chairperson

Rhonda Bullard presented in Kristina's absence. The committee met February 12, 2024, to discuss the committee's role in supporting the CWC management team, who are increasingly effective in rolling out communication improvements and initiatives. The committee also reviewed how to expand communications regarding other Board committee's initiatives or action items to help shareholders be informed and avoid miscommunication or concern due to lack of helpful information.

The committee reviewed upcoming shareholder events on the lake and Borad participation in them., specifically regarding the upcoming Easter Egg Hunt & WET N Wild Boat Rally.

Again, it was emphasized that shareholders should have their email address on file with the lake office, please call or drop by as the office continues to utilize more and more communication methods via email addresses and optimizing the office's systems. There are no action items at this time.

With no other business, President Gary Mapes adjourned the meeting at 6:25

# CODE COMPLIANCE CORNER

With the recent heavy rains, I thought this would be a good time to share the rules regarding erosion, sediment and drainage.

**Construction Rules and Regulations** 

### VI. REMOVING TOPSOIL, AND FILL DIRT AND RESPONSIBILITY FOR DRAINAGE:

**A**. A shareholder must secure a permit from CWC before adding or removing any gravel, topsoil or fill dirt to or from CWC property. *Shareholders will be required to install approved erosion and sediment control measures.* 

**B**. A shareholder will be solely responsible for all drainage problems on a leased lot including the cost of engineering, design, and necessary remediation.


**C**. A shareholder may not expand lot surface area by encroaching into the lake using retaining walls or other devices.

An approved erosion and sediment control measure is addressed by installing a Silt Fence. As part of our permit application, we have provided diagrams and recommendations for the proper installation of a silt fence. I am posting them here for your reference.

### Silt Fence Notes:

- 1. Filter fabric is to be Mirafi 100X or approved equal.
- 2. Steel posts which support the silt fence shall be installed at a slight angle toward the anticipated runoff source.
- 3. The toe of the silt fence shall be trenched in with a spade or mechanical trencher so that the down slope face of the trench is flat and perpendicular to the line of flow.
- The trench should be a minimum of six inches deep and six inches wide to allow for the silt fence to be laid in the ground and backfilled.
- 5. Silt fence should be securely fastened to each support post.
- Inspection shall be frequent, and repair or replacement shall be frequent, and repair or replacement shall be made promptly as needed.
- Accumulated silt shall be removed when it reaches a depth of six inches. Sediment trapped by this practice shall be disposed of in an **approved site** in a manner that will not contribute to additional siltation.
- Contractor to remove silt fence upon completion of project. Damaged areas to be repaired including re-grading and regrassing as necessary.

# CWC Spring Clean-Up Friday, April 19<sup>th</sup> - Sunday April 21<sup>st</sup>

During this period, both the North Side and South Side roll-off container sites will be open between the hours of 10:00 am and 5:00 pm Friday and Saturday and 1:00 pm to 5:00 pm Sunday. The sites will be manned by CWC employees. Residents may bring up to two (2) pickups full (approximately 6 yards) of non-hazardous household waste to the container sites for free disposal. If you need more than six (6) yards, please call the CWC office, to make arrangements. All waste must originate from leased property at Lake Cherokee.

Rather than list what we will be accepting, let me list what we will not be able to accept. We will not be accepting any of the following:

- Hazardous materials of any kind
- · Liquids of any kind (examples: paint, solvents, cooking oil, etc.)
- Items that contain PCB's (i.e., transformers)
- Yard waste such as trees, limbs, grass clippings, etc.
- Shingles and roofing materials
- Tires
- Mattresses
- Dishwashers
- Construction Materials

Many of you wish we could accept yard waste and tree limbs, etc., unfortunately we cannot. To help with this problem, the CWC has arranged for shareholders to obtain, from the CWC office, landfill vouchers to dispose of these items at the Pine Hill Landfill. These vouchers are good for two (2) trips per year. Please call us for details of this program.

Through special arrangements, we will be able to accept some items that are not allowed at the landfill.

These include:

- Some appliances including those that contain Freon such as air conditioners, refrigerators, and freezers
- Vehicle batteries will only be received at the north side disposal site

To participate in the cleanup, you must bring the items for disposal and proof that you are a shareholder at Lake Cherokee to the disposal sites during the dates and times given above. Proof may be in the form of a Privilege Card showing you are a shareholder or shareholder's spouse. In addition, a valid DL or other photo ID is required. If the shareholder or shareholder's spouse will not be present (i.e., you have arranged for someone else to transport your material for disposal,) you will need to call the office and make arrangements. This cleanup is for household waste only from the shareholder's Lake Cherokee lot. No commercial disposal will be allowed.

Please take this opportunity to improve our environment, improve the quality of life for all of us on the lake and protect our community.

This is the second in a series of articles on our U.S. Armed Forces. Each month will highlight a different branch. It will culminate with an article on our veterans coinciding with Veterans Day in November.

# The U.S. Army "This We'll Defend"

The Army is the oldest and largest of the branches of service. First known as the Continental Army, it was founded June 14, 1775, when open hostilities from British forces required an organized and effective response from the nascent Continental Congress. The vote to establish the Continental Army upped the regional rebellion to a war for independence. The next day, George Washington was appointed commander of all Continental forces. Since then, the Army has been involved in many conflicts and operations but only five formally declared wars, the last one being World War II.

Organizationally, the Army has two components: active and reserve. Active duty includes over 200 specialized jobs. Army Special Forces Soldiers, including Green Berets and Rangers, are trained for special missions including using unconventional tactics to fight terrorism. The Army Reserve and Army National Guard allow the country to quickly respond to national emergencies with on-call trained soldiers. The Guard is a reserve unit organized and controlled by each State.

Texas houses several Army commands including Army Futures in Austin, Army North and Army South at Fort Sam Houston in San Antonio, and III Armored Corps at Fort Cavazos (formerly Fort Hood) in Killeen. Fort Bliss near El Paso is the second largest military installation. Army Medical Command is based out of Fort Sam Houston and provides not only medical, dental, and veterinary support but also develops medical concepts and doctrine through research. Through studying traumatic limb injuries during the 2001-2004 Global War on Terrorism, Army research led to a revised view by global surgical experts on the use of tourniquets to control life-threatening bleeding. Advancing civilian trauma care is another reason to be grateful for the sacrifices made by our soldiers.

The Army's Military Academy is in West Point, New York. The annual Army-Navy football game began in 1890 and pits the Black Knights against the Midshipmen in one of the greatest sports rivalries (Black Knights prevailed this December. Go Army!).

Historically, the most famous Army recruitment slogan was "I Want YOU



for US Army". A more familiar slogan (and its catchy jingle) was "Be All You Can Be" (1980-2001) which was ranked as the 18<sup>th</sup> best advertising campaign in the 20<sup>th</sup> Century and has just recently been brought back by the Army to attract a new generation of recruits.

Some famous Army names include: the first female to serve, Deborah Sampson, who disguised herself as a man and fought against the British during the Revolutionary War; the Tuskegee Airmen, a group of African American airmen in WWII; the Rough Riders (the First US Volunteer Cavalry) who fought in the Spanish American War; and the Lewis and Clark expedition that surveyed the newly purchased western territories. Other famous Army veterans include Gen George Patton, Elvis Presley, Clint Eastwood, Gene Roddenberry, and George Straight.

A notable Army medal of honor recipient was Desmond T. Doss, a conscientious objector and Seventh Day Adventist who volunteered after Pearl Harbor because he wanted to serve. He refused to carry a weapon and served as an Army medic. His noted heroism came from the Battle of Okinawa in 1945 when he risked his own life to rescue 75 wounded men from a battlefield as portrayed in the movie Hacksaw Ridge.

More locally, Private First-Class George Benton Turner of Longview served with the 14<sup>th</sup> Armored Division during WWII and received the Medal of Honor from Harry S. Truman who stated, "I would rather have that medal than be President of the United States." More awe-inspiring stories of Texas Medal of Honor recipients can be found at the Texas Medal of Honor Memorial currently displayed at the International Artillery Museum in Saint Jo, Texas. Every story is worthy of a Hollywood movie! Finally, a word from some of our own Lake Cherokee Army veterans. "After serving 3 years in the Army and 2 years overseas, it will make you appreciate the good old USA. Living on Lake Cherokee is a bonus." Bruce Bussey, (Vietnam era)

"Military life. Memories to last a lifetime. Friends/comrades in arms that share a common bond." Bob Tippit (Sergeant, 1970-73)

"My wife and I went through Desert Storm together. I know that I would serve again today without hesitation. I am proud to have served and it set my life in motion completely different than where I thought it was headed. All of it to land here at Lake Cherokee. We couldn't be happier!" Mike Armstrong (Sergeant, 1985-93, 1<sup>st</sup> Calvary Division "America's First Team!")

# Lake Cherokee Veterans Memorial

The Lake Cherokee Veterans Memorial design is nearly finished, and construction bids are being solicited. It will be located on the peninsula near the fuel center. Six military flags, a POW/MIA flag, a Texas flag, and a Lake Cherokee flag will surround the existing American flag. The flags will be illuminated at night. A short decorative wall with an engraving will be seen from the water. The project consists of 2 phases. Phase 1 includes the display of flags and the wall that will be viewable from the water. Phase 2 will make the Memorial accessible on foot via Persimmon Point and includes construction of the brick memorial walls, benches, and concrete walkway surrounding the flags.

A mock-up military flagpole currently stands next to the American flag on the site. You can see it by land (peak over the fence near the fuel center) or by sea if you dare brave the cold windy temperatures. We are excited that Elliott Electric will donate lighting fixtures that will allow us to keep the flags illuminated 24 hours a day. Thanks Jerry Camp! Thomas White continues to work with suppliers and crews to develop a budget for each phase. The current donations held by the CWC are roughly 1/6 of the cost for Phase 1. Fundraising for the remaining amount will begin with a snail-mailer to all shareholders offering different ways to donate including ways to memorialize your veterans.
