LEASE RENEWAL REMINDER

The annual lease renewal is here. Payment is due on the first day of October and is considered late on the first day of November, and incurs a \$100 late fee. An additional \$100 will be charged for each month thereafter.

If the split payment option is chosen, the first half is due on October 1st and will not be accepted after October 31st. After November 1st, the split payment option is no longer available. The second half of the split payment is due on the first day of April, 2024 and is considered late on the first day of May.

Neither the lease application nor the annual lease payment can be accepted or processed by the staff until all of your fines, fees and penalties are satisfied. For late payment penalty purposes, the application or payment is not considered submitted until the day that the fines, fees and penalties are paid.

President Christy Bussey called the meeting to order.

Cathy Hite, Secretary, pronounced a quorum.

Minutes of the July 20, board meeting was discussed, reviewed and stand approved as distributed.

President's Report:

Christy shared this is a busy time for the board as they develop budget for 2023 -2024. She shared that board elections are coming up and we are looking for new members to apply. The shareholder survey will remain open until August 22nd so there is still time for shareholders to provide input. Any questions should be directed to Misty Conway in the office. The survey is one tool that is used to develop priorities for Cherokee Water Company.

General Manager's Report

In Kevin's absence, President Christy Bussey provided an operational update

including stats on administrative, patrol and maintenance departments.

Treasurers Report:

Randy Graves, Treasurer made a motion to certify the bills paid for the month ending July 2023. The second was made by Seleta Davis. The motion passed unanimously.

Randy Graves made a motion to approve the financials ending July 2023. The second was made by Rhonda Bullard. The motion passed unanimously.

Committee Reports: Community Relations Committee:

Rhonda Bullard reported in Kristina Coolidge Committee Chair absence. 2023 is Cherokee Water Company's 75th anniversary. The committee will be working with Shareholders to develop a display to be available at the Annual Shareholders meeting and following that commemorates the 75-year history of the lake.

Reminded the board that the Lake Cherokee Shareholders page is run by shareholders and is not the "official" CWC page and board members should use the CWC page for communications. No action at this time.

Road and Boat ways Committee:

Gary Mapes, Chair reported the committee did not meet this month. He shared the status of the road improvement project. The 1st part of the project between the Dump site and storage facility has been completed. The project is now on hold until the temperature returns to the 90s to ensure the successful installation of the materials. No action at this time.

Rules and Policies Committee: Rhonda Bullard, Committee Chair reported.

2nd reading: Current Rule: On-Site Sewage Facilities Rules and Regulations, VI. Fees for the Use of CWC Unleased Land for the Disposal of Wastewater, reads: Any Shareholder that uses unleased CWC property for OSSF purposes will be subject to annual fees, other than a spouse, a resident as designated on the annual lease, or a one-time generational transfer to a family member.

Proposed Change: Any Shareholder that uses unleased CWC property for OSSF purposes will be subject to annual fees, other than a spouse or a onetime generational transfer to a family member. Rationale: Stock transfer to a spouse or one-time generational family member is grandfathered from paying the fee for spraying on unleased CWC property.

Rhonda Bullard made a motion to approve. A second was made by Paul Oberthier. Motion passed unanimously.

1st reading:

Construction Rules & Regulations, IV. Houses, Mobile Homes, and other Buildings, C. suggested rule change; wording submitted by Bruce Rucker, Johnson & Pace:

Current Rule:

No permits will be issued on any lot that has not been surveyed. For surveying procedures, see Section B (4): SURVEYS AND ESTABLISH-MENT OF LOT LINES. Work must be commenced within ninety (90) days from the date on which the permit is issued. For a residential structure, all exterior construction must be completed within twelve (12) months. For all other non-residential structures, all work must be complete within six (6) months from issuance of the permit. Permit extensions may be issued at the discretion of the Lake Manager or his/her designee for verifiable delays. Failure to comply with the above timeline requirements will result in fines of one thousand dollars (\$1,000.00) per month. Any work which commences without the issuance of an appropriate permit may be immediately stopped by the Lake Manager or his/her designated representatives.

Proposed Change:

No permits will be issued on any lot that has not been surveyed by a Texas RPLS; the Survey must be tied to the CWC Control Network, property corners should be located or relocated, based on the lot corner coordinates on file at the CWC office from previously approved surveys. All surveys must be approved by the CWC office. For surveying procedures, see Section B (4): SURVEYS AND ESTABLISHMENT OF LOT LINES. Work must be commenced within ninety (90) days from the date on which the permit is issued. For a residential structure, all exterior construction must be completed within twelve (12) months. For all other non-residential structures, all work must be complete within six (6) months from issuance of the permit. Permit extensions may be issued at the discretion of the Lake Manager or his/ her designee for verifiable delays. Failure to comply with the above timeline requirements will result in fines of one

thousand dollars (\$1,000.00) per month. Any work which commences without the issuance of an appropriate permit may be immediately stopped by the Lake Manager or his/her designated representatives.

Rationale: A survey must be done by a Texas RPLS according to state law. The survey is tied to the CWC Control network and matches what is on file.

Variance Requests

The committee had 2 variance requests for consideration this month. ST05 – requesting to encroach into water with new retaining wall so frontage is linear vs the current curved retaining wall.

Rhonda Bullard moved to approve the variance. A second was made by Randy Graves. The motion passed unanimously.

NF 32 – add .190' of privacy fence that is 8' tall.

Rhonda Bullard moved to approve the variance. A second was made by Paul Oberthier. The motion passed unanimously.

Strategic Planning Committee

Rhonda Bullard Committee Chair reported.

As a number of initiatives that began 12-24 months ago are coming to fruition it is exciting to see how the Strategic plan has and will continue to play a large part in moving forward. The progress of these goals and action plans are being updated by the General Manager and will be input for establishing the budget and capital expenditure priorities. The initial plan was developed after the last Shareholder survey. The current survey results will give us additional feedback. The Strategic plan will be updated and available at the Annual Shareholders meeting in November.

Other Business

Cathy Hite announced that the August board meeting will be her last meeting as she accepted the position of Office manager with the departure of Marie Hooten in September. Christy Bussey shared that Marie and Tommy Hooten are leaving on September 15th. We wish them well on their next adventures.

With no other business, President Christy Bussey adjourned the meeting at 6:30 pm.


CWC Office Manager

Summertime is winding down and with that comes hot temperatures and very little rain. At the time of this memo, the current water level on Lake Cherokee is more than a foot below normal and we are urging boaters to be vigilant when on the water.

Boaters should use caution when launching as some ramps may be impaired by low water. Boaters should be vigilant and try to remain in the main creek channels and give the shoreline a wide berth. Some areas may harbor obstacles just below the surface such as stumps and sand bars that are normally in deeper water. Slow down and be especially careful at night. Depth finders can be a useful tool to help navigate the waterways and give you a good idea of how quickly the water depth can change. We strongly encourage all boaters to wear a life jacket when on the water and remember that children under the age of 13 are required to always have one on while the vessel is underway.



Vegetation Management Right-Of-Way Line Clearance Tree Maintenance


During the next several months, Rusk County Electric Cooperative, or its utility line clearance contract crews, will be pruning limbs and removing trees in the electric overhead power lines rights-of-way in your area. This work is being done to eliminate potential safety hazards and to keep power outages to a minimum. It is our desire to provide safe and reliable electric service to you. Since the last right-of-way clearing in your area, small trees may have grown or been planted within the right-of-way. These trees will need to be removed so your co-op can continue to provide safe and

dependable electric service. If you want to keep any of these trees, go ahead and transplant them away from the power line right-of-way. A Rusk County Electric Cooperative, or an authorized contract representative, will attempt to contact you either in person, by phone, or by a notification card before removing trees within a landscaped or regularly maintained area. If routine prunin is all that is required (as performed during the previous re-clearing cycle), you may not be contacted. Catfish Seminar, September 2023



We had around 35 people attend our first catfish seminar. I want to thank everyone that came out on a hot Saturday morning.

Everyone got a bag that had hooks, weights, and rags and all that you need to get set up to go catfishing. We showed how to tie on hooks and different kinds of baits that most people use at our lake.

John Coward had been baiting the lake pier all week with cattle cubs to help bring in catfish. We all went out to the pier to try and catch fish. Bonnie Hegeman was the only person to catch a fish. She was excited. Don Anderson, George Steele, Bruce Slover and his friend Tony showed everyone how to fillet your catfish. Thanks to Bruce and Tony for bringing some catfish they had caught where we would have fish to clean.

Thanks to East Tex Sonar and Wings and Whitetails in Carthage for their donations of bait and hooks for our seminar. Please thank these stores for their support of our club.

One thing we didn't go into was how

to make chum. You need a 30 gallon plastic trash can with a lid. Next you need 3 bags of either milo or chicken scratch. Empty this into your trash can and add either 1 bottle of beer or a packet of bakers yeast. Add 2 cups of sugar and cover with water till seeds are about 2 inches under water. You can use a piece of PVC pipe about 6 feet long to stir this mixture up. Put lid on trash can and let set for several days. Recheck in about 3 days to see if still has water about 2 inches over mixture. Let set for about 1 week and if will ferment in real hot weather real quick. When ready to go fishing use a 1 gallon plastic jug and fill up with chum. When you find your spot, pour about 3 or 4 cups of chum in water and wait about 30 minutes and the fish should be coming to eat. Oh, this stuff really stinks so be sure to have you some rags to wipe your hands. Good Luck.

If there is any other kind of seminar the club would like to have, let me know and I will try and put one together.






This month's recipe is from Roxanne Lane-Brink, our Lake Cherokee "First Friends" coordinator. She has been making this casserole for over 40 years and assures me that it is guick, easy and delicious!

Ground Beef Casserole

Roxanne Lane-Brink

Ingredients

1 lb ground beef (browned with 1/4 cup chopped onion), drained 1 can (10.5 oz) cream of mushroom soup

- 1 can whole or cut green beans, drained
- 2-3 small potatoes, peeled and sliced

salt and pepper to taste

Putting it together . . .

Layer cooked ground beef in a 2-1/2 quart baking dish. Sprinkle with salt and pepper.

Add drained can of green beans and spread evenly over ground beef.

Add layer of potatoes next and top with undiluted mushroom soup. Spread soup over the sliced potatoes and sprinkle with paprika or parsley flakes.

Bake covered at 350 degrees for 1 hour or until potatoes are done.

If you prefer a more "soupy" consistency, add another can of undiluted soup between the ground beef and green bean layers.

Tree Permits

Need a permit to remove a dead or diseased tree? You don't have to come to the office but remember you must secure a permit from CWC before cutting trees from any CWC property. All trees that are requested to be removed shall be clearly marked. This can be done with a bright colored ribbon, spray paint or a paper plate tacked to it. Once you have the tree/s marked, call the Cherokee Water Company office and request a staff member to come to your lot to evaluate the tree/s and approve, if applicable, for a tree cutting permit to be issued. Trees smaller than ten inches (10") in diameter, thirty inches (30") from the ground, may be removed without restriction (although a permit is still required.) Any tree removed from CWC property without securing a permit will result in a fine being issued to the shareholder in the amount of \$250.00 per tree.


