



This month we have been busy in the office with Lease Renewals. Thank you to everyone that embraced the transition to the Portal and renewing online. I know that change is not easy and some of you are not fond of technology, but together we are making it happen.



My vision for next year is that it will be even easier. I want to say thank you to Lori Klump for working with me and providing her experience / expertise as well as insight as a shareholder.

As of this writing, we have processed about 65% of the renewals and you should be receiving your privilege cards and decals in the mail. If you have not processed your renewal, you may have missed an email and need to contact us ASAP.

November 14th is our Annual Shareholders meeting. I will be emailing the Meeting packet which will contain your proxy. To conduct business at the meeting, there must be a quorum. So, watch your email or if you don't have an email, your mailbox to return the proxy by the deadline. For those with an email, your proxy will be online, and you will have until the day of the Shareholders meeting to register your proxy.

Our primary communication method is going to be email and postings in the Portal. The reason for this is efficiency but also for security reasons. You can send us messages through the request page in the Portal. We check our inbox regularly. A lot of the information on social media is incorrect and just causes more confusion and frustration for everyone. We have an Official CWC Facebook page where we will post messages if the message is for public consumption.

You will not see us in the office, respond to comments or posts on the Lake Cherokee Shareholders Facebook page. That doesn't mean that we don't see or hear about some of the information posted.

Each month, I will try to "FACT CHECK" some key points or address "FAKE" news.

1. As shareholders, you believe that you should be consulted and / or vote on key business decisions.

The bylaws give shareholders the right to vote on the Board of Directors. These are your representatives. The ethics policy that governs the Board states - A member of the CWC Board of Directors holds a fiduciary responsibility to fairly represent all the shareholders and the operations of Cherokee Water Company to the best of their ability. Kevin, as the CWC General Manager discusses key business topics with the board and depending on the specific situation or requirements the board will vote on the request.

2. It was suggested that we put together a list of shareholders' expertise and experience and leverage them vs hiring/paying for engineers or other consultants.

This might sound like a good idea until you consider liability issues. Certain projects such as road repairs, dam repairs or projects where permits may be required, bonded and insured contractors are required by our insurance company. This doesn't mean that others don't have valuable input or expertise. However, this type of input would be considered "opinions "and utilized accordingly to not put CWC at risk. As stated above, Kevin leverages the Board of Directors and gains their approval according to the rules and bylaws.

3. It was requested that we record or stream the board meetings.

Currently, we are not planning on recording or streaming the board meetings. I have done some research regarding the recording of board meetings. The recording of board meetings requires us to consider privacy and legal concerns. Recording could lead to the inappropriate disclosure of confidential information. With today's advanced technology of Artificial Intelligence (AI) we have to consider recordings falling into the wrong hands. We post our minutes in the Chatter so everyone can read about the meeting. Until our boardroom is better equipped with technology (i.e. Multiple microphones) there are challenges with live streaming. We have done some live streaming of meetings in the past and had challenges with ensuring that people online could hear and see the events. For now, if you want to "listen" to the board meeting, you need to attend in person.


### JEFF PATTY

### MINUTES OF THE BOARD OF DIRECTORS CHEROKEE WATER COMPANY Thursday October 17, 2024

A meeting of the Board of Directors of Cherokee Water Company was held at 6:00 pm on Thursday, October 17, 2024, at NK 20 Lake Cherokee, Longview Texas 75603 with the following Directors present:

President Gary Mapes called the meeting to order at 6:00 pm

Dee Rea, Secretary, pronounced a quo-

Gary Mapes made a motion to approve the minutes of Board of Directors Cherokee Water Company, September 19, 2024. Seconded by Alan Koelemay. The resolution passed by unanimous consent.

Gary Mapes reported that the Election Commission met on Wednesday, October 2. The report stated that the four positions on the Board of Directors with terms expiring had candidates apply and, according to the Bylaws, met all required standards and therefore were certified by the Election Commission. No other applications were received. In accordance with the Bylaws, (CWC Bylaws, Article 4, Election Commission & Election of Director's, Section 4) the Election Commission recommends to the Board of Directors that the election not be conducted and that the certified candidates be deemed elected as Directors.

A motion was made by Gary Mapes and seconded by Randy Graves to accept the recommendation of the Election Commission to cancel the election and deem Jeff Patty, Justin Simmons Cody Edmondson and Mary Yoder as Directors. The motion passed with unanimous consent.

#### **General Manager's Report:**

Kevin provided an operation report including stats on administrative, patrol and maintenance departments. Other items reported on:

- 1. Kevin gave an update on the south road project (sections SA to SG). As of Friday, the laying of asphalt should begin with the completion of the project within one week.
- 2. Hawk Island Project, now named Eagle Cove, is finished with the exception of planting grass and leveling the bottom of the cove.
- 3. The Beaver Run Lots have been listed for sale. The price is \$400,000.00 for both.
- 4. The Carp fence has been completed.
- 5. The annual audit will begin Monday, October 21. The report should be ready by the Annual Shareholders Meeting in November.

#### **Treasurers Report:**

A motion was made by Randy Graves to certify the bills paid for the month ending September 20 24. Dee Rea seconded the motion. The motion passed unanimously.

Randy Graves provided an overview of the Financials. Revenue is slightly higher than budget. The expenses were about 10% lower than the budget due to the efforts by Kevin Jones and Cathy Hite in managing expenses. Audited Financial Statements will be available for Shareholders at the Annual Shareholders Meeting in November.

A motion was made by Randy Graves to approve reporting of Financials for September 2024. Dee Rea seconded the motion. The motion passed unanimously.

Rules, Policy & Variance Committee:

### Paul Oberthier presented variances to the Board for consideration:

Three Variance Requests were considered.

**SL 73**, to build a new boathouse 185 ft. into the lake. The water was measured at 5 ft. deep at 185 ft. This request was revised from one presented last month

requesting to build 210 ft. into the lake and was denied by the BOD at the September BOD meeting. The existing boathouse currently extends over the adjoining lot line with SL 72. The new boathouse will be moved to the west to be within the SL 73 lot lines. Both adjacent shareholders have signed off. The committee visited the site in September and recommends approval of the revised request. Paul Oberthier made a motion to approve the variance. Rhonda Bullard seconded the motion. Kristina Coolidge recused herself from voting.


NH 21, to build an accessory building that will not have a 4/12 pitch roof and will not have an overhang. The building will have a 3/12 pitch roof. The building will have gutters on one side for drainage control. Both adjacent shareholders have signed off. The committee visited the site and recommended approval of the request. Paul Oberthier made a motion to approve the variance and Alan Koelemay seconded the motion. The motion passed with unanimous consent.

NG 5, to build a new carport that will be closer than 6 ft. to the property line. The carport will be 2 ft. from the property line on one corner. Both adjacent shareholders have signed off. The committee visited the site and recommended approval of the request. Paul Oberthier recused himself in the vote. David McDaniel made the motion to approve the variance and Randy Graves seconded the motion. The motion passed with unanimous consent.

### **Other Business**

Kristina Coolidge requested an Update on the Portal and Online Lease Renewals from Office Manager

Cathy Hite, Office Manager, provided an update on the rollout of the Online Lease Renewal process via the Portal. She estimated that about 70-75% of the leaseholders have completed their lease agreement online. Many stated they were scared of the technology but worked with us to complete online form. It only takes about 5 minutes to complete. About 50% of those still prefer to pay their lease payment via a paper check or delivery payment to the office. Approximately 30% have made their payment via the e-check option which is new this year. By completing the lease agreement online, it will make it even easier next year as even more information such as privilege cards will be pre-populated. Thank you



to everyone for completing this via the portal. In addition, she reported that approximately \$21,000 in donations have been collected for the fireworks. This represents almost 50% of the cost of the fireworks.

In addition, she reported that shareholders should check their emails or mailbox for the Annual Shareholders Meeting packet. This year, those with emails will be asked to register their proxy through the portal. We need a quorum for the meeting to conduct business, so we need shareholders to complete their proxy or attend the meeting in person. Shareholders will be able to use their email address and password for the Portal to complete.

With no other business, President Gary Mapes adjourned the meeting at 6:25 pm.



### "An Undeniable Honor"

### **Voices of Lake Cherokee Veterans**

Have you ever said a word so much that you forget its meaning? I sit at my laptop now; after writing 9 months of articles about our US Military and I'm stuck on this word "Veteran." We use labels to help others characterize people. Labels such as "Lawyer" "Nurse" "East Texan" "Republican" "Swiftie" conjure up images in our minds, so that we can better understand them. After 9 months of learning about all the branches of the military, their actions, their histories, their status, their heroes...well, to me labeling someone a "Veteran" doesn't characterize them, it just adds mystery to who they are. What was their unique experience that endowed them with this label "Veteran"? In this final Chatter article, I asked them. I heard from 11 of our Lake veterans and a child of parents who served and who grew up on base. This article wasn't easy. Some folks were reluctant to speak, and I had to prod them. But here I present to you, THEIR voices.

"A *Veteran* is any service member that has served a minimum time after they became a job qualified member of their branch of service. It doesn't matter if they are retired, active duty, medically discharged, or discharged after their initial contract. A lot of people think the title of veteran is only for people who retired after 20+ years or have been to combat, but it covers a broad range of service members" says Miguel Fabbiani, lake resident and Master Sergeant in the US Army. If you come to the Gala on November 16<sup>th</sup>, try to meet him. He's been our military protocol expert and a passionate supporter of Veterans and our Memorial.

### Ok, that's a definition, but what does it mean to be a Veteran?

Pride was an emotion that most felt by having served. "Part of something bigger than yourself" said one Veteran. Two Veterans mentioned that 1% of our Nation serves and they were proud of being in this group. When asked how often he thinks about his time in the service, one stated, "Daily, it's part of your DNA." Some display their service outwardly such as one Veteran who has a USMC emblem "Eagle, Globe, and Anchor" on his golf bag and Yeti beer koozie. While others wear it inside such as one Veteran whose service

makes him "inwardly proud and gives me a quiet sense of pride." It was an "undeniable honor."

### Why did they enlist?

"I did my duty to God, Country and the Corps." Another felt the need to serve and to fight for "those that can't fight for themselves." Another "never gave it any thought to volunteer and serve our nation." Some had no choice such as a child of active-duty parents whose father became disabled from a head injury in the Navy and a mom who was an Army nurse. She stated, "There was a lot of worry and uncertainty because you don't have control over your own life. The military decides it all. Most people make decisions based on what's best for their family. You don't get this luxury when you're enlisted. You do what the government tells you to do, and your spouse and children comply."

### Why is it so important to serve?

Overwhelmingly: FREEDOM. Some recognized that "seeing the world" gave them a better appreciation for the United States. One stated he was "God Blessed to be born an American." Another felt that the "freedom to be upset with actions or persons of this country" was a privilege granted to Americans because of those "willing to wear the uniform." Another noted that the US Miliary fought for ideas and against "bullies" and was not out to conquer, because "the only land we gained is the Cemeteries where our military are buried." Of course, not all military experiences are Tom Cruise dog fights. Many experiences bordered on being mundane. One Veteran was a Captain of the US Dental Corps who "somewhat wished that I could be more involved in the military aspect of the Army as my two brothers were" but understood his role was quite necessary. Another Veteran proclaimed he was "PROUD of 3 sons that chose to serve and defend."

### What do they ask of you?

One theme that generated from our veterans was a plea to not forget those who sacrificed. "I only hope that others will appreciate all those that have served." "Never forget the sacrifice

the men and women in uniform have made for their country." "Never forget those who volunteer to serve our country." "Be supportive to those who defend your freedom. Do not take them for granted." "I want people to reflect on why it is that we have a free nation. A lot of men and women sacrifice their rights to protect our country and the free world. I want them to honor the memory of all who have served and especially those who died in service to our country."

#### And, their hope for the Veterans Memorial?

That it becomes a sacred place where people can "reflect" "remember" "honor" "pay tribute" "appreciate" "be grateful" "salute to service" "never forget" and "feel thankful." They want the Memorial to recognize Veterans and tell them that "their service is acknowledged and appreciated." And, not just for Veterans, but also for those who "continue to serve" and those "who are considering service." They hope that the flag display triggers these emotions in everyone, as it does themselves. One Veteran stated that the American flag is "the biggest symbol of freedom in the world." Another wants the Memorial's American flag to be a "beacon of hope" and represent what this "great country means."

#### Crappie - A Species Profile

#### Introduction

Crappie is the common name used to describe two species of freshwater fish from the sunfish family (Centrarchidae) which also includes bass and sunfish species. Black crappie (Pomoxis nigromaculatus) and white crappie (Pomoxis annularis) are the two species that can be found throughout much of the United States and in Lake Cherokee.

#### Identification

These species can be difficult to distinguish from one another as they occupy the same habitat space, consume the same forage, exhibit similar behavior, and like other fish species color morph to their surroundings. Proper identification in pond management is important, as black crappie are less prolific than white crappie, and as a result do not overpopulate as rapidly in smaller water. Lake cherokee is large enough to support both species with proper management but further breakdown for identification purposes is provided below.

#### Black Crappie


Black crappie are a round and flat fish that typically have silvery green back with white to silver sides and unorganized speckled black dots across the body. Black crappie tend be slightly thicker and heavier at the same length as white crappie.

#### White Crappie

White crappie look very similar to black crappie. They also exhibit a round, flat body shape with a silvery green back, silvery sides, and block spots, however, their spotting tends to be more organized in the form of vertical bars along the sides and back. White crappie also tend to be slightly thinner than black crappie of the same length.

#### White vs. Black Crappie (Proper identification)

The most accurate way to identify black from white crappie is NOT by color because both species are capable of changing colors to fit their surroundings, and can look identical in murky water but rather by dorsal spine counts. Black crappie with have 7-8 dorsal spines and white crappie will have 5-6 dorsal spines. The following photos depict what to look for.



#### Data Collection 2023 to 2024

In 2023 we collected 84 crappie data points and determined that the average relative weight of the fish collected was 88.4%. Meaning that both black and white crappie in the lake were overpopulated, which is common without high harvest rates. As a result, we helped implement harvest rule changes and encouraged individuals to harvest more crappie from the lake in order to help bring numbers back in to balance.

Recently, we helped host a crappie tournament on lake cherokee where several teams competed, and we were able to collect 30 new data points for 2024. The crappie turned in during this tournament had an average relative weight of 89.4% which means harvest efforts from just one year have already shown improvements in the fish being caught.

In the next month we will be conducting an electrofishing survey to get further data on the fish present in Lake Cherokee. Results so far, indicate that the new harvest plans being implemented by shareholders on the lake are already having an impact on the overall health of the fish in the lake. We encourage everyone to continue harvesting fish and working to improve the quality of the fishery in the lake. We have created a database that can be shared with everyone to log their catches and harvests so that we can better plan for each year ahead. 




