MINUTES OF THE BOARD OF DIRECTORS CHEROKEE WATER COMPANY Thursday, March 20, 2025

A meeting of the Board of Directors of Cherokee Water Company was held at 6:00 pm on Thursday, March 20, 2025, at NK 20 Lake Cherokee, Longview Texas 75603 with the following Directors present:

Gary Mapes, President David McDaniel, Vice President Randy Graves, Treasurer Dee Rea, Secretary Kristina Coolidge Justin Simmons Cody Edmonson Cory Eason--- Absent Mary Yoder---Absent Alan Koelemay George Steele Jeff Patty

President Gary Mapes called the meeting to order at 6:00 pm Dee Rea, Secretary, pronounced a quorum.

Dee Rea made a motion to approve the minutes of Board of Directors Cherokee Water Company, Thursday, February 20, 2025 and the Special Meeting of the Board held on Monday, February 24<sup>th</sup>, 2025. Second by Randy Graves. The resolution passed by unanimous consent.

#### **General Manager's Report:**

Kevin provided an operation report including stats on administrative, patrol and maintenance departments. Other items reported on:

1. Kevin is in communication with the City of Longview regarding contributing to the cost of silt removal within Lake Cherokee. Talks are described as productive.

2. Kevin is in consultation with management of the Knox Lee Power Plant concerning the amount of sedimentation being deposited into the lake at the end of the discharge canal. The sides of the discharge canal are eroding into the canal, and the sediment is being carried into the lake.

3. The maintenance department will begin removing sediment from all siltation pond locations this coming week.

4. Kevin will engage in a conversation with Austin Lightle, P.E., representing Hayes Engineering, Inc. this week concerning the design and engineering of siltation ponds at the NQ Cove, Eagle Cove and Mud Creek. 5. Kevin showed pictures of the finished new island that is positioned behind Firecracker Island. It will be used for additional boat parking and picnicking.

#### **Treasurers Report:**

A motion was made by Randy Graves to certify the bills paid for the month of February 2025. Dee Rea seconded the motion. The motion passed unanimously. A motion was made by Randy Graves to approve reporting of Financials for February 2025. Dee Rea seconded the motion. The motion passed unanimously.

Rules, Policy & Variance Committee: David McDaniel, Chairman

Committee Members: Cody Edmonson Alan Koelemay Cory Eason---Absent George Steel

#### **David McDaniel presented variances to the Board for consideration:** Four Variance Requests were considered:

SB 40: The Committee voted unanimously to approve a variance to add to an existing home and deck. David made a motion to the Board to approve the variance. Cody Edmonson seconded the motion. The motion passed unanimously. SG 35: The Committee voted unanimously to approve a variance to build a carport closer than 50 feet from the road. David made a motion to the Board to approve the variance. The motion was seconded by Cody Edmonson. The motion passed unanimously. SG 53: The Committee voted unanimously to approve the variance to demolish an old boathouse and construct a new boathouse in 4.9 feet of water at 96 feet from land. David made a motion to the Board to approve the variance. The motion was seconded by Randy Graves. The motion passed unanimously. SL 37: The Committee voted unanimously to approve the variance to build a carport cover on an existing slab close to the road. David made a motion to the Board to approve the variance. Randy Graves seconded the motion. The motion passed unanimously.

#### Rules Changes:

David McDaniel presented the following rule change.

**Current Rule:** General Rules & Regulations, I. General Provisions; C: Rights and Privileges of Shareholders and Others:

3.B. Firecracker Park gate access privilege cards will be issued (upon request) ONLY to shareholder, shareholders' Spouse and unmarried dependent children under the age of 25. These cards are required to access the entrance and exist onto Firecracker Park.

#### Proposed Rule Change, First Reading:

3.B Firecracker Park gate access privilege cards will be issued (upon request) to shareholder and shareholder's spouse.

The shareholder and shareholder's spouse privilege cards reflect the access code and are required to access the entrance and exist onto Firecracker Park.

**Rationale:** Instead of a gate access card, a gate code is issued to the Shareholder. Shareholder is responsible for the use of their entry code and for the behavior of their guests that access the park.

#### Current Rule: General Rules &

Regulations, I. General Provisions; C: Rights and Privileges of Shareholders and Others:

3.G. Should a shareholder's spouse or resident no longer reside with the shareholder, it is the shareholder's responsibility to recoup the privilege card held by such a person and return it to the office. If not returned, no new privilege cards will be issued for spouse/resident until the previously issued card expires.

# **Proposed Rule Change, First Reading:** 3.G. Be Removed completely

**Rationale:** Resolves itself with each renewal. Difficult to enforce as we don't know when someone moves out.

**Current Rule**: General Rules & Regulations, I. General Provisions; F. Lake Lot used for Residential Purposes Only

4. Commercial Billboards, political signs, real estate signs without permit from CWC and advertising of any description are prohibited.

#### Proposed Rule Change, First Reading:

5. General Contractors may place a sign for identification purposes once a construction permit is issued and removed when the construction project is completed. The sign can be no larger than 24X20 and contain: LOT number; name of general contractor or DBA and contractor phone number. There can be no logos or advertisements.

**Rationale**: Assist subcontractors in locating the correct LOT/JOB for deliveries.

**Current Rule:** Construction Rules & Regulations V. Piers, Boathouses and other Structures Over the Water E. These standards shall be applied for new construction and for the reconstruction or rewiring of such existing. facilities. Shareholders take full responsibility for ensuring water safety from all electrical risks caused by faulty, non-

compliant electrical service to their piers, docks, and boathouses. Shareholders are responsible for ensuring their structures' electrical service is completed under the direction of a licensed electrician.

1. The wiring method shall be of a type identified and accepted for use in wet locations. All wiring below seven feet from the floor of the pier, dock or boathouse shall be contained in PVC or rigid conduit. All wiring shall be properly sized to the breakers.

#### Proposed Rule Change, First Reading:

E. These standards shall be applied for new construction and for the reconstruction or rewiring of such existing facilities. Shareholders take full responsibility for ensuring water safety from all electrical risks caused by faulty, non-compliant electrical service to their piers, docks, and boathouses. Shareholders are responsible for ensuring their structures' electrical service is completed under the direction of a licensed electrician.

1. The wiring method shall be of a type identified and accepted for use in wet locations. All wiring below seven feet from the floor of the pier, dock or boathouse shall be contained in PVC conduit. All wiring shall be properly sized to the breakers.

**Rationale**: Rigid conduit a hazard around water

#### Natural Resources Committee Meeting

Dee Rea, Chairman Committee Members: Justin Simmons Cody Edmonson David McDaniel Alan Koelemay, absent

The Committee met to discuss designing and building siltation ponds with Austin Lightle, P.E., a representative of Hays Engineering, Inc. We explained to Mr. Lightle our desire for him to design and engineer sedimentation ponds at the NQ Cove, Eagle Cove and Mud Creek. Permits from any state and federal governing bodies necessary for construction must be obtained. We would want 3 competitive bids for the engineered project. We also explained that there are approximately 14 siltation ponds around Lake Cherokee, and we would like to get all the other ponds assessed.

The sedimentation spoil removal in the NQ Cove has been divide into Plan A or Plan B.

### Plan A:

1) Funded by Shareholder Pope to remove the island and sand bar in the NQ cove.

2) Spoil would be removed and deposited on his land located across the lake road from the NQ Cove.

3) He would also remove sediment throughout the cove, Increasing water depth, and property values in the cove.

4) Cherokee Water Company would require the work to be defined and contracts signed.

#### Plan B:

1) Removal of existing spoil in the NQ Cove.

2) Engage in silt removal up into the cove.

3) Use the island as a platform for an extended arm excavator to remove silt as fat into the cove as possible.

4) Transport silt off the lake to a designated location.

5) Bid requests have previously been sent out. We reviewed the responses and noticed a substantial difference in cost and methodology.

Committee requests a firm plan be put forth for Plan A by June 15, 2025 or we move forward with Plan B.

We also discussed the need to move forward with crown thinning and underbrush removal in selected areas. A discussion needs to be made with Kevin and President Mapes on how best to precede.

We would like to study the Surface Rights Agreements pertaining to these wells. Even though the Braden Head pressures have been reduced on these wells a review of the Surface Rights Agreements would be appropriate. We ask Kevin or Cathy to provide these agreements to the BOD for review.

The committee urges the General Manager to organize the maintenance department to remove sediment spoils at the sedimentation ponds. This should be accomplished at the earliest possible time.

With no further discussion the meeting was adjourned at 4:00 PM.

## WHO NEEDS THE BOATER EDUCATION CARD?

Texas Parks & Widthe Department Contract of the States of Anyone born on or after September 1, 1993 who wishes to operate certain vessels on the public waterways of Texas.

It's the LAW!

Operators must meet the age and boater education requirements shown below in order to operate any of the following vessels legally in Texas:  $\cdot$ 

- A powerboat powered by a motor of more than 15 horsepower or...
- A personal watercraft or...
- A windblown vessel over 14 feet in length.

A person less than 13 years of age may operate only if he or she is supervised by a person who:

- Is 18 years of age or older and...
- · Can lawfully operate the watercraft and...
- · Is on board when the vessel is underway.

A person at least 13 years of age and born on or after September 1, 1993, may operate without supervision only if he or she has passed a boater education course that is accepted by Texas Parks and Wildlife.

Save the date: The Boater Education Course has been set for Saturday, June 7, 2025, at CWC, NK 20.

On the Portal there is a direct link to the official Lake Cherokee Store. There is also a QR code in the chatter each month that will take you directly to the Store. The store has not gotten enough traction this past year. There is a **short poll on the Portal dashboard** where you can provide us with some feedback on how we could improve the store. Your feedback is important as we consider options and directions in the upcoming year. We have most of the current items in the CWC office if you would like to see the items.

Now, I need to rant a bit. I have a couple of posts on the Shareholder Portal of recent events around the lake. I did not put these on the CWC Facebook page as that is a public page. # CWC Spring Clean- Up Friday, April 11th – Sunday April 13st

During this period, both the North Side and South Side roll-off container sites will be open between the hours of 10:00 am and 5:00 pm Friday and Saturday and 1:00 pm to 5:00 pm Sunday. The sites will be manned by CWC employees. Residents may bring up to two (2) pickups full (approximately 6 yards) of non-hazardous household waste to the container sites for free disposal. If you need more than six (6) yards, please call the CWC office to make arrangements. All waste must originate from leased property at Lake Cherokee.

Rather than list what we will be accepting, let me list what we will not be able to accept. We will not be accepting any of the following:

Hazardous materials of any kind

Liquids of any kind (examples: paint, solvents, cooking oil, etc.) Items that contain PCB's (i.e.,

transformers)

Yard waste such as trees, limbs, grass clippings, etc.

- Shingles and roofing materials
- Tires
- Mattresses
- Dishwashers
- **Construction Material**
- Mini Refrigerators

Many of you wish we could accept yard waste and tree limbs, etc., unfortunately we cannot. To help with this problem, the CWC has arranged for shareholders to obtain, from the ČWC office, landfill vouchers to dispose of these items at Pine Hill Landfill. These vouchers are good for two (2) trips per year. Please call us for details of this program. Through special arrangements, we will be able to accept some items that are not allowed at the landfill.


#### These include:

· Some appliances including those that contain Freon such as air conditioners. · Vehicle batteries will only be received at the north side disposal site

To participate in the cleanup, you must bring the items for disposal and proof that you are a shareholder at Lake Cherokee to the disposal sites during the dates and times given above. Proof may be in the form of a Privilege Card showing

you are a shareholder or shareholder's spouse. In addition, a valid DL or other photo ID is required. If the shareholder or shareholder's spouse will not be present (i.e., you have arranged for someone else to transport your material for disposal,) you will need to call the office and make arrangements. This cleanup is for household waste only from the shareholder's Lake Cherokee lot. No commercial disposal will be allowed.

Please take this opportunity to improve our environment, improve the quality of life for all of us on the lake and protect our community.

Bryce Tawney, Secretary/Treasurer, provided a financial update for February. Bryce reported that a Berkley fishing line recycling bin will now be available at monthly meetings. He recently visited and emptied the PVC recycling receptacles at the NA and Silvey Bridge boat ramps and is securing signage for greater visibility. Bryce advised members that the Cherokee portal has CFC forms and documents for brushpile coordinates and the Spring Memorial Bass Tournament. Bryce encouraged members to join the CFC Group within the Cherokee portal. The Spring Memorial Bass Tournament is on Saturday, March 22, and entry forms need to be received by Genia (SD14) or dropped at the CWC Office (NK20) by 3 p.m. Thursday, March 20.

Bryce congratulated new member Kevin Thompson on his 9.86 lb. largemouth bass caught last week. Kevin was kind enough to share details of his catch.

George Steele, Habitat Director, reported the habitat team has finished replenishing existing brush piles with Christmas trees. Later in the spring, willow saplings will be gathered and placed. Thanks to Danville Farms for donating trees and the time and effort of CFC volunteers to improve our fishery.

Gary Lindsey, Hatchery Director, reported that 2 of the brood ponds are raising bluegill and redear sunfish. 

### **Terrestrial Herbicides - Avoiding Negative Effects**

#### Introduction

The warm season is officially approaching and with the onset of warm weather comes the arrival of undesirable weeds both in ponds and lawns. Fortunately, now is an excellent time to take action against pesky yard weeds and other pests; however, when living near a lake there are some things to be mindful of prior to performing a treatment. Many formulations of weed killer and insecticides designed for lawns can be problematic for aquatic life including fish. It is very important to make sure that the products being used on your lawn are labeled for the aquatic environment because when it rains that is where product residues will end up!

#### Herbicides

There are a number of different herbicides available for terrestrial use, many of which have the same active ingredient as aquatic brands. For example, Roundup is a Glyphosate product that is labeled for use on land. Glyphosate is also approved for use in aquatics, but roundup is not. Roundup, despite being a glyphosate product, is toxic to aquatic organisms. This is not because of the glyphosate itself but rather the surfactant and other products mixed into Roundup. This is true for many other terrestrial herbicides as well. Most of them contain products such as surfactants with the chemical that can be damaging or fatal to aquatic organisms. But how do you know what is or is not low risk?

Prior to purchasing a product for treating your lawn, always be sure to check the product label. You can access product labels on the internet or by looking at the papers that are glued on to the front of the product container. On the label will be information regarding where and how the product can be used safely. Below is an example from Roundup Pro. This chemical formulation is harmful for aquatic life and therefore it is against the label to use it in areas where surface water is present or where it could wash into an aquatic environment.

### 2.2 Environmental Hazards

Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment washwaters.

In addition to environmental hazards the label will also indicate where the product is designed to be used. This is typically on the very front of the product under the name. Aquatically labeled products will always include an aquatic section on the label. Below is a clip from the Roundup Custom label, where it clearly states that this product can be used in aquatic sites as well as other areas.

## **Complete Directions for Use**

Roundup Custom<sup>™</sup> for Aquatic and Terrestrial Use is a complete broad-spectrum postemergence herbicide for aquatic, crop, non-agricultural crop, industrial, turf, ornamental, forestry, roadside, and utility rights-of-way weed control.

#### Insecticides and Pesticides

Herbicides not designed for aquatic use are not the only products that can have negative side effects. Many pesticides and insecticides can also be harmful to aquatic life. It is important to always read the label for pesticides as well as herbicides and only use products in accordance with the label. Below is a clip from the label for Bifenthrin, a common broad spectrum insecticide. As you can see, this product is also not recommended for use near surface water and could potentially have negative side effects.

#### ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish and aquatic invertebrates. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters. Care should be used when spraying to avoid fish and reptile pets in/around ornamental ponds.

#### Summarv

Remember, the label is not only a guide on how to apply the product, it is also federal law. Misuse of a product against its label is considered a violation of federal law and is subject to penalty. So, always read and follow the label for both your safety and to avoid causing unintentional negative side effects to the aquatic environment around you. The good news is there are a number of aquatically labeled formulations of commonly used products such as Roundup Custom (glyphosate), Weedar (2,4-D), and more. Always check and follow the label as well as local and state laws.

In May I will be celebrating my second work anniversary as Compliance Officer for beautiful Lake Cherokee and I could not be more grateful for the journey so far! Since my time here, I have met a community of incredible people, heard wonderful stories of the lake's history, and gained an unspoken understanding that life on the lake means something deeper than just a home; it is a way of life.

My role as Compliance Officer has been to review and issue permit applications, conduct site inspections, investigate violations, and provide guidance to property owners and contractors by helping them understand the permitting process and their responsibilities. You may ask why compliance matters in private lake matters? The answer to that question is construction and modifications can impact the surrounding environment and neighboring properties. Compliance helps to ensure responsible development on Lake Cherokee.

Having a home on a private lake offers unique opportunities for recreation and enjoyment, but it also comes with responsibilities, especially when it comes to construction and modifications. Before starting any project, please call me or stop by to discuss the permit and rules that apply to the specific permit needed for your project. By doing this, you can avoid the consequences of non-compliance which consist of stop work orders, monetary fines, and penalties.

Also, as Compliance Officer, I frequently find myself acting as a buffer between neighbors who have differences when it comes to property matters. I am here to help but I highly encourage neighbors to have a conversation with one another first whenever possible. Whether you are discussing property boundaries, projects, or shared responsibilities, maintaining a **healthy and productive conversation with a neighbor** can help prevent misunderstandings, avoid unnecessary tensions, and build mutual respect, especially when together you are focusing on solutions, not blame. By trying to address concerns directly and constructively, we create a more peaceful, cooperative, and connected community.

# AUTHORIZED WATERCRAFT

 Lot Number required on ALL BOATS, PERSONAL WATERCRAFT



**Texas Water Safety Act** 

Only boats, personal watercraft and other water vessels registered in the name of the shareholder or shareholder's spouse with registered address matching CWC records

## PROHIBITED BOATS ON LAKE CHEROKEE

- Boaters > 28 feet in length
- Houseboats
- Boats with permanent sleeping facilities
- Boats with sanitation facilities
- Amphibious aircraft ٠
- Airboats or swamp boats
- No motors with open exhaust

# **OPERATION OF WATERCRAFT**



Privilege card holder must be born before Sept 1, 1993 unless operator is 13 years of age or older and has passed a boaters education course; or is accompanied by a person at least 18 years of age and can lawfully operate the watercraft

## SPEED LIMITS & BOAT SAFETY

- Not above idle speed within 50 ft of any vessel, person, shore or stationary object
- NO speed in excess of 40 mph in open or ski waters (day) or 30 mph (night)
- 30 mph in named boat roads
- 10 mph access boat roads



# WAKE BOATS

Empty water-filled ballast systems prior to traveling on boat road. Ballast bags containing solid materials such as steel shot, gravel or sand shall be moved to the center-front of the Wake Boat. Passengers much move to the front of the Wake Boat.

# WATER SKIING

- Restricted to open water marked by buoys and no closer than 150 ft from piers and boathouses.
- Any boat pulling water skis require a min. of 2 people in the boat so that driver can keep proper lookout.
- All skiers are required to wear approved flotation device.
- PWC can not pull a person or persons on water skis on Lake Cherokee

## PROHIBITED BOATING AND FISHING AREAS



- No closer than 100 ft to carp fence
- No boating in the SWEPCO canal or City of Longview water intake area
- No tying boats to buoys

## SWIMMING

- Only Privilege Card Holders and guests are allowed to swim in Lake Cherokee
- Prohibited from the spillway to Section NB, from the dam, SWEPCO canal, boat roads and City of Longview intake area or CWC office piers






